

## The Countdown to Christmas Sweepstakes Official Rules

**NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.**

Participation constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules. The "Countdown to Christmas" Sweepstakes begins at 12:00 a.m., Eastern Time ("ET") on November 26, 2021, and ends at 11:59 p.m. ET on December 26, 2021 ("Sweepstakes Period"). Sweepstakes is sponsored by Churchill Mortgage Corporation (the "Sponsor") 1749 Mallory Lane, Brentwood, TN 37027.

**Eligibility:** Sweepstakes is only open to legal residents of the 50 United States, including the District of Columbia, who have the age of majority in his or her state or territory of residence and as of the time of entry. Employees, officers, and directors (including immediate family members and members of the same household) of the Sponsor, affiliated companies, subsidiaries, retailers, distributors and advertising and promotion agencies, and any other entities directly associated with this sweepstakes (collectively, "Released Parties"), are also not eligible to participate. All federal, state, and local laws and regulations apply. **Void where prohibited.**

**How to Enter:** During the Sweepstakes Period eligible participants will be invited to participate in an online survey to enter the Sweepstakes. Once the survey is completed, they will be invited to opt-in to the Sweepstakes by completing a registration form with their name, email address and mailing address which will result in one (1) entry into the Sweepstakes. A total of up to 15 entries per person will be allowed.

All requested information on the Sweepstakes registration form must be completed for an entry to be eligible for the drawing. **LIMIT one (1) entry and fourteen (14) extra entries per person, per email address during the Sweepstakes Period.** Enter using only an email address subscribed and registered in your name. Once submitted, any entry cannot be deleted, canceled, or modified. In the event of a dispute as to Online Entries submitted by multiple individuals using the same email account, subscriber is deemed to be the natural person who is assigned an email address by an Internet access provider, online service provider or other organization which is responsible for assigning email addresses or the domain associated with the submitted email address.

**Drawings and Notifications:** Four (4) random drawings will take place to determine the winners which will all be conducted by Alliance Sweepstakes Services (“the Administrator”), an independent judging organization, whose decisions are final and binding in all matters relating to this Sweepstakes. Administrator will randomly select one (1) First Prize Winner from among all eligible entries received up until the time of each drawing on December 2, December 9, and December 16, 2021, for a total of three (3) First Prize Winners. Administrator will then randomly select one (1) Grand Prize Winner from all eligible entries during the Sweepstakes Period on or about December 27, 2021. A Grand Prize Winner is deemed the Winner pending confirmation and/or verification of his/her eligibility and compliance with these Official Rules as determined by Sponsor and Administrator in their sole discretion.
